Who are the Erasmus+ National Focal Points?

- Erasmus+ National Focal Points (ENFPs) represent the lifeblood of the Erasmus+ mission within third countries not associated to the Programme. They are selected by their nation's governing entities such as the ministries overseeing higher education to be the champions and standard-bearers for the Erasmus+ activities within their borders.
- As an ENFP, they are entrusted to increase the reach and accessibility of the Erasmus+ programme in their country.
- Their goal is to ensure that every potential applicant and beneficiary, regardless of their field, can tap into this reservoir of educational and professional development opportunities.
- Their support is the keystone to embedding the Erasmus+ programme deeply into the fabric of the Non Associated Third Countries region.
- They are more than a point of contact; they are the mentor, guide, and local beacon for prospective applicants and beneficiaries, ensuring the programme's goals resonate at both the national and regional levels.
- Given the complexity of the Erasmus+ programme and the breadth of opportunities it offers, their role is of vital importance. As a guiding figure, they provide the necessary assistance and clarity to navigate the programme's processes, making them more approachable for all potential applicants.
- As outlined in the ENFP Terms of Reference, their appointment is a badge of trust and expectation, bestowed by national authorities and affirmed by the EU Delegations.
- Their mandate is clear: to weave the Erasmus+ vision into the local narrative.
