Building on the My eQuals platform New Zealand universities have initiated a Credit transfer project which will enable students to transfer academic credit more easily when they change university provider.

Refreshing the New Zealand Curriculum

The Ministry of Education is two years into a six-year programme to refresh the New Zealand Curriculum. The refreshed curriculum will support every ākonga (learner) in experiencing success in their learning. It will give effect to Te Tiriti o Waitangi, and will be inclusive, clear about the learning that matters, and easy to use from year 0 to year 13. The refreshed curriculum content is being developed and released in phases, and schools and kura will have until the beginning of 2027 to use the fully refreshed curriculum.

Legislative reforms and/or policies that have been put in place in the past three years or that are still being discussed

Code of Pastoral Care

The code of practice for the pastoral care of domestic tertiary and international learners came into effect on 1 January 2022. All tertiary education providers and schools enrolling international students are expected to comply with the code. The code sets out the expectations that tertiary education organisations and schools enrolling international students must meet for learners' safety and wellbeing.

Establishment of Te Pūkenga (New Zealand Institute of Skills and Technology)

Te Pūkenga is New Zealand's largest vocational education provider. In 2019 the NZ government announced that the country's 16 Institutes of Technology and Polytechnics would merge with effect from 1 April 2020. This merger is still being worked on and refined.

Initiatives and/or programmes that have been launched in the past three years

Disability Action Plan

In 2022, the Tertiary Education Commission (TEC) introduced a new investment plan requirement: disability action plans (DAPs) to encourage and support TEOS in taking a strong and proactive approach to improving outcomes for disabled learners. Requiring DAPs as part of the investment round is part of the Government's move to ensure TEOs meet their responsibilities under the United Nations Convention on the Rights of Persons with Disabilities.
