Heritage Based Education 5.0

Heritage Based Education 5.0 represents a transformation in higher education, evolving from the traditional Education 3.0 model (focused on teaching, research, and community engagement) to a more comprehensive approach that adds innovation and industrialisation. This model emphasises using local heritage — such as flora, fauna, and cultural resources — to create goods and services that address societal needs. The goal is to integrate knowledge and heritage into practical applications that contribute to economic and social development.

Second Science, Technology and Innovation Policy Of Zimbabwe

The Second Science, Technology, and Innovation Policy of Zimbabwe outlines the country's strategy to promote and develop science, technology, and innovation (STI). The policy focuses on leveraging STI to drive economic growth, enhance industrialization, and improve the quality of life. It aims to foster research, innovation, and the application of technology across sectors, contributing to sustainable development and global competitiveness.

National Technical and Vocational Education and Training Policy

The TVET Policy focuses on providing students with practical skills aimed at producing goods and services, as well as fostering self-employment. Training programmes are designed to emphasise innovation and industrialization. A key priority of the policy is aligning qualifications with both the Southern African Development Community (SADC) and the Continental Qualifications Frameworks, ensuring regional and international recognition of skills.

Legislative reforms and/or policies that have been put in place in the past three years or that are still being discussed

Manpower Planning and Development Act

The Manpower Planning and Development Act is Zimbabwe's key legislation for human capital development. It aims to:

- Support the national strategy for skills planning and development.
- Promote university, technical, and vocational education focused on producing goods and services.
- Ensure operational independence for technical, vocational institutions, and teacher colleges.
- Advance science, technology, engineering, and innovation to drive industrialization and modernisation through research and higher education institutions.

University Acts

The University Acts in Zimbabwe have been reviewed to align with Heritage-Based Education 5.0. This transformation expands the focus from the traditional model of education (Teaching, Research, and Community Engagement) to include Innovation and Industrialization, emphasizing the use of Zimbabwe's natural resources (flora, fauna, and people) to produce goods and services that meet societal needs.

Initiatives and/or programmes that have been launched in the past three years

Establishment of innovation hubs, industrial parks and science parks

Innovation hubs, industrial parks, and science parks have been set up at universities throughout all ten provinces of the country. These facilities aim to foster innovation and support research and development efforts within the academic and local communities.
